PRESIDENT'S REPORT

That certainly was a beautiful summer that held on with high temperatures well into October. Now for the breathtaking colours of a Canadian autumn that grace Foley Mountain Conservation Area. Such a spectacular time of the year. You will see from Rebecca's report that summer was busy as always at Foley Mountain, and that this lovely fall weather has also been very welcoming for park visitors.

The major administrative project undertaken by the Board was amending our Letters Patent and By Laws to be in accordance with Ontario Not For Profit Corporations Act. Sandy Cameron was responsible for this initiative, and I would like to thank him for his hard work.

The necessary amendments were outlined in a letter to current Members prior to the Annual General Meeting and were approved by the Members at the meeting on May 15th.

The Articles of Amendment were endorsed and certified by the Director/Registrar, Ministry of Public and Business Delivery on July 18, 2024.


As required by the Ontario government, copies of the amended By-Laws were sent to the Charities Directorate, Canada Revenue Agency and the Office of the Public Guardian and Trustee.

Of note in the amendments to the Letters Patent, now known as the Articles of Amendment, was Special Provision 'f' which states; "Directors shall be the only Members of the Corporation." As a consequence, the term "Friend" has replaced the term "Member" on the new application form. Maintaining the pre ONCA membership organizational structure would necessitate extensive communications and reporting requirements that are beyond the capacity of our volunteer board

The Rideau Valley Conservation Authority has raised its parking fees at the five conservation areas that charge fees. The daily rate is now \$8, and a monthly pass is \$55. Consequently, we have raised the fee for a contributing friend to \$55. Friends paying the \$55 fee or above will receive the yearly pass. This fee as well as the new terminology is reflected in the revised friends forms attached to this newsletter.

Later this fall we will be selling another jig saw puzzle as a fund raiser (pictured next page). The puzzle is produced by a company in Merrickville and is high quality. The puzzle will be available at various Westport locations – it would make an excellent Christmas present to those puzzle lovers on your list. More details will be published on our Facebook page.

- We have loved seeing so many people out in the park and enjoying all that Foley Mountain has to offer. Summer was busy as always but this lovely fall weather has also been very welcoming for park visitors. We are looking forward to a busy Thanksgiving weekend!
- We are again very fortunate to be benefiting from funding from the Rideau Valley Conservation Foundation and Bogs to help schools with program and bussing fees for trips to Foley Mountain. Many days are fully booked between school visits and forest school!
- Our fall forest school program is well underway with four days of programming. We are so happy to offer these programs for children and families to adventure, play, and learn in the forests of Foley Mountain. Registration for winter programs will open soon!
- Our 2024 day camp season flew by with four sold out weeks! Our days were jam packed with exploring, play, creating, and more. We also added some public programs to the summer schedule to gauge interested in this type of format. We'll be reviewing the program over the winter to determine our plans for summer 2025!
- The facility rentals program continues to be well subscribed with many Girl Guides, Scouts, and community groups making great use of the Interpretive Centre and Group Camping areas for their spring and fall camps.

The following history of the McCann farm was prepared by Dan Grunig for the 50th Anniversary of the Foley Mountain Conservation Area. Dan's wife, Joey, is related to Ted and Katie McCann. The McCann farmhouse is now the home of park superintendent Rebecca Whitman and her family.

Ted and Katie McCann Farm on Foley Mountain

The "McCann Farm" is on a 100 acre piece of property on the north half of Lot 11 Concession 5 (Township of North Crosby) on Foley Mountain.

In 1844, the Crown deeded land on the Mountain to the Canada Company, a company that was set up by the government in Upper Canada to encourage settlement. In 1889, the Canada Company sold Lot 11 Concession 5 (200 acres) to Declan Foley for \$500. One should remember that most of the Mountain burned in 1870 so it was no longer valuable for harvesting timber after the locals salvaged the burnt timber.

In 1897, Mary Foley (the window of Declan Foley) sold the north half of Lot 11 Concession 5 to Mary O'Grady ("Spinster", as described in the land records) for \$300. The 1921 Census indicates that Mary O'Grady was living with her nephew and his wife, Michael and Mary Ellen O'Grady so the farm house must have been built some time between 1897 and 1921.

In 1931, Mary O'Grady sold the property to her nephew and his wife for \$2,300. In 1943, Mary Ellen O'Grady (widow of Michael) sold the property to Terence (Ted) McCann for \$1,700. Ted and his wife, Catherine (Katie) then sold their farm on Concession 8 to the Pollard Family and moved to the Lot 11 Concession 5 property.

In 1965, Ted and Katie McCann sold the property for \$3,500 to Jim and Gladys Kenney (Gladys is the daughter of Ted and Katie McCann) who carried on the farming activities.

In 1971, Jim and Gladys Kenney sold the farm to the RVCA for \$25,000.
